**Subject :** JES Mother Teresa College of Nursing, Bangalore, Regarding admission To Pc BSc (N) course.

**PREAMBLE :-** 1. JES Mother Teresa College of Nursing, Bangalore has submitted the application for the affiliation for the year 2010-11 for starting the Pc BSc (N) course to the RGUHS, As per section 45 of RGUHS Act, 1994, Based on this requisition the local enquiry committee has Inspected the college & submitted its Report. After the consultation with the academic council and the syndicate 30 seats are sanctioned for Pc.BSc (N) course & the information about same are sent to the government for approval.

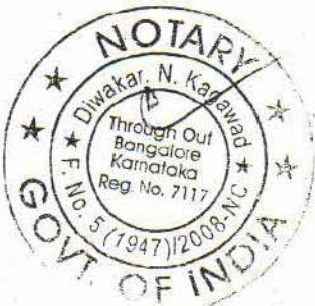
In view of the above subject government has scrutinized the documents and has sanctioned 50 seats for the commencement of fresh admission to Pc BSc Nursing course for the Academic year 2010-11.

2. As per section 45 and sub- Rule (5) of the RGUHS Act 1994, Exercising the mandatory power, JES Mother Teresa College of Nursing is recommended to admit 50 students of Pc BSc (N) course for the academic year 2010-11 subject to the following conditions.

**CONDITIONS :-**

1. JES Mother Teresa College of nursing, Bangalore shall Reserve 20% of seats for Pc BSc (N) course for candidates admitted through government Quota.
2. Prior to starting Pc BSc Nursing course, affiliation sanction has to be obtained from RGUHS.
3. Approval should be obtained from the Indian Nursing Council According to rule 13, of Indian Nursing Council Act of 1947 & shall abide by the rules and regulation framed by the Indian Nursing Council mandatarily. The Institution shall provide basic fundamental facilities required for running the course as laid down by the RGUHS, KNC & INC.
4. As per the Indian Nursing Council Act of 1947 and sub rule 13 only after obtaining official permission form Indian Nursing council the admission can be made. In any circumstance. No additional Intake of students is permitted. If found violating the rules as per 1991 Act of Kamataka affiliation will be with drawn & criminal proceedings will be undertaken for the same.
5. Institutions and directions given by RGUHS, Government of Kamataka, Kamataka Nursing council, from time to time must be observed.
6. As per the directions of the Indian Nursing Council own hospital should be possessed with the maximum period of 5 years failing which the recognition will be with drawn.

7. Admission of students should be strictly made in accordance with the rules and regulations of the Karnataka Nursing, Pharmacy & Physiotherapy courses of 2003. The college shall abide by the ordinance with regard to Government Quota seats reserved by Government for MSc Nursing, MPT and M.Pharm courses and shall admit students under Management Quota as per the limits sanctioned.
8. The above college shall not receive any grant or any kind of financial assistance to run this course. This is permanent grant as an unaided college.
9. If the college is found to violate any of the above Mentioned conditions, as per the 1994 Act sub rule 48 of RGUHS, affiliation to the college will be with drawn.



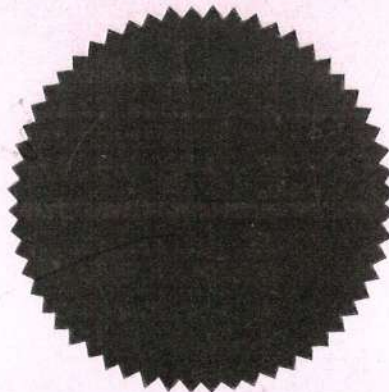


